## Annual Plan 2022-23 Monitoring Q1

## Background

- 1. The 22-23 plan is in a new format developed by a NWIFCA committee of members. Instructions for quarterly monitoring of the plan have not yet been prepared.
- 2. This report provides necessary amendments to the plan since it was prepared and brief monitoring comment on work and progress for each of the success criteria and work streams listed in the plan.
- 3. There are 27 Success criteria in the plan and 38 Work streams. Monitoring this complex plan could be very onerous for officers all of whom already have full work programmes
- 4. The report below provides below very brief monitoring comments on the success criteria and work streams in the plan ordered by page number. Quarterly reports provide considerable additional detail on the implementation of many of the success criteria and work streams.

Page 16. Fisheries Management Plans FMP have been made a Defra priority workstream. A number of national FMP are now in development including Bass and Channel non-quota species. When Defra give the signal to proceed, NWIFCA will lead on developing a national cockle FMP and assist other IFCA with a mussel FMP This work will assist with development of NWIFCA District FMP for cockles and Mussels.

P18 Work on MPA is continuing and up to date. Allonby Bay is under consultation by Defra as a potential HPMA (Highly Protected Marine Area).
