PATROL AND ENFORCEMENT QUARTERLY REPORT – <u>1ST MAY 2017 TO 31ST JULY 2017</u>

Recommendation: The report is received

<u>Area Summary</u> A summary of activity for the quarter by area is as follows:

<u>Staff</u>

- Southern IFCOs underwent net measurement training
- Officers attended mandatory safety courses as required
- IFCO Walters sadly departed the IFCA to join Lancashire Constabulary
- Three IFCOs (Sparks, Walters and Brownrigg) continued working through the accreditation scheme

<u>Byelaw Review</u>

As agreed by the Technical Science and Byelaws (TSB) Sub-Committee on the 16th May a consultation on the proposed measures for the new Byelaw 3 has been carried out.

A very brief summary of the consultation is given below:

- The consultation ran from the 7th June 2nd July and was website based
- 51 submissions were received
- The consultation was based on 11 regulatory areas and gave background on the area and asked for the rationale of the answer

A full consultation summary presented to TSB on the 8th August including 11 recommendations summarised in the Technical, Science and Byelaws Committee Report.

The agreed measures will be included in the first draft of a new Byelaw 3 in addition to the following already agreed:

- The byelaw would only regulate the hand gathering of cockle and mussels
- The main feature of the byelaw will be a flexible permit scheme
- The permit will be for both species as a dual permit as in the current Byelaw 3

TSB members were invited to forward additional written suggestions to the HoE on the measures. This invitation is extended to all members. Please send comments by end September.

NWIFCA Byelaw 3 Permits

The current Byelaw 3 permit numbers are:

2016/17	 121 in total 106 currently issued, 2 with cheque clearing and 11 have not renewed. 2 still outstanding on the waiting list due to a low number of foreshore gatherers safety courses being run and only short notice of courses being received.
2017/18	94 in total have been issued to date
	85 renewals and 9 from the waiting list

The maximum possible number of permits for 2017/18 is 120 if all those who are eligible renewed.

In preparation for cockle's fisheries starting 1st September the following was done in July – August to aid permit renewal:

- Permit renewal application forms were posted to all permit holders to prompt renewal;
- Text message reminders were sent;
- IFCOs were instructed to encourage prompt renewal when meeting permit holders.

All renewal applications received in time were processed and permits issued for September 1st.

Health and Safety

The review of the IFCAs Health and Safety policy and procedures continued during the quarter. A near miss in relation to the lone working policy occurred during the quarter.

Fishery Specific Issues

Cockle and Mussel Fisheries

Cockle beds were closed and there was no Mussel fishing in the District during the quarter.

Byelaw 3 Returns Compliance

Enforcement action was taken against 19 individuals who had failed to provide returns for the Leven and Pilling cockle fisheries for the all or part of 2016- May 2017.

The sanctions taken are summarised below:

- 12 official warning letters were sent
- 7 advisory letters were sent
- 5 permit suspensions were undertaken when non-compliance continued with 4 subsequently complying

18 of the 19 individuals have supplied the required returns. One permit suspension remains in place for non-compliance. This individual may have left the District.

The above action was designed to encourage good compliance with returns requirements in autumn cockle and mussel fisheries.

Byelaw 6 "Grandfather" Clause

Byelaw 6 (Protection for European Marine Site Features) prohibits the use of mobile gear in a number of areas within the district – including Shell Flat and Lune Deep.

The byelaw contains a historic access clause in paragraph 6d as follows:

"the applicant's fishing vessel remains in the same legal and beneficial ownership as on the date of this byelaw being made"

The list of vessels holding grandfather rights contained 4 vessels when the byelaw was made. During the last quarter 2 changes in vessel ownership were detected. Vessels owners were informed that they did not hold Grandfather rights. One of the vessels continues to be used in the district.

Two vessels remain on the list.

<u>Bass</u>

The regulation (article 9 of Council Regulation 2017/127) was in force during the quarter and saw the transition with respect to recreational catches from catch release to one Bass per person per day – on the 1^{st} July.

No compliance issues with respect to this were detected.

Recreational Bivalve Activity

From mid-June onwards a number of instances with respect to predominantly IC5 individuals collecting various bivalve species were reported or directly detected.

This activity was at a higher level and more spread out through the district than the normal predictable activity that occurs on the North Wirral coastline.

Summary points for member's information:

- Generally the activity was targeted and involved non-regulated species such as Razor clams and other species
- In some cases (see sanctions section) official warning letters were sent in relation to cockle gathering
- In two cases the reports went direct to the police and resulted in a Coastguard response
- Press releases generated further press queries including from the BBC

In response to the above clarification was placed on the IFCAs website on the 18th June and a multi-agency meeting was held with police/MCA etc. to agree lines of communication and appropriate response levels.

Shore Based Activity Report

A summary of shore based activity is given in the table below. Areas the IFCOs focused on during the quarter were:

- High levels of patrol presence on the North Wirral coastline specifically targeted at intelligence on Cockle poaching activity
- Bass compliance focused patrols
- ATV patrols to check on Byelaw 26/27 permit requirements
