BYELAW REVIEW

Purpose: Update Byelaw review discussed at TSB August 2016.

Recommendation: Approve revised byelaw review as set out below

Background

- This report is a summary of the August 2016 byelaw review report to TSB.
- 2. The 2009 Marine Act (MACAA) S155–162 set out enhanced IFCA byelaw making powers. Statutory Instrument (SI) 2011 No 603 MACAA (Transitional and Savings Provisions) Order transferred SFC and other inshore fisheries byelaws to IFCA so that the existing byelaw regime remains in force revides by the Authority.
- 3. In 2011 Defra published new byelaw making guidance and requested IFCA create a coherent regulatory regime by reviewing inherited byelaws. A byelaw review continues but was delayed by higher priority work, in particular the EMS review.

The NWIFCA Byelaw review progress

- 4. While the byelaw review is underway all existing byelaws continue in force. Inherited byelaws are repealed when replacement NWIFCA byelaws come into force. There is therefore an effective functional byelaw regime in place and no loss of fisheries regulations as a result of the setting up IFCA.
- 5. NWIFCA inherited a uniquely complex byelaw regime from of two SFC Districts and EA byelaws for the Dee Estuary. The Dee was not previously part of the SFC District having been regulated by the EA.
- 6. While some inherited byelaws follow common themes in the different areas, the three or more sets of inherited byelaws are mostly significantly different in content and purpose. The NWSFC and Cumbria SFC had different fisheries requiring different management solutions. Unsurprisingly, the two SFCs developed different approaches to tackle the issues. Dee byelaws add another level of complication.
- 7. Since 2011 NWIFCA has introduced the byelaws listed in Table 1. Despite the Government intentions expressed at the inception of MACCA, that byelaw making would be speeded up this has not been the case in practice. Not only are recent byelaws more complex, the byelaw making process has more stages including requirement for regulatory impact assessments, increased consultation and sign off by two Government Departments (MMO and Defra).

8. Byelaw work must be done along with higher priority essential statutory duties so resources are limited. A schedule of one byelaw per year is a reasonable target. Limiting factors are the requirements for consultation with stakeholders before and after the byelaw is made, the requirements for approval by the Authority at various stages in the byelaw making process and the capacity of the MMO byelaw team to quality check all IFCA and MMO byelaws.

Byelaw work in progress

- 9. Since 2011, work has started on a number of NWIFCA byelaws as shown in Table 2.
- 10. Table 3 provides an overview of the planned outcome of the byelaw review resulting in replacement and repeal of inherited byelaws.
