Introduction

- 1. NWIFCA is the lead statutory regulator under MACAA for protection of the marine environment and sustainable use of sea fisheries resources within its District. The Authority's duties are defined in MACAA Sections 153 to 184.
- 2. S177 requires each IFCA to publish as soon as practical after the end of each year a report on the work of the Authority for that year. The report may be used by Defra to measure the performance of the Authority, accountability and value for money.
- 3. **IFCA Vision** (Defra 2009): To lead, champion and manage a sustainable marine environment and inshore fisheries in its District by successfully securing the right balance between social, environmental and economic benefits to ensure healthy seas, sustainable fisheries and a viable industry.
- 4. Priorities for the year 2016-17 were set out in the 2016-17 Annual Plan. Outcomes and delivery are summarised in Annex C the Authorities objectives and Annex B the Defra 2015 monitoring template.

The Authority: Members, meetings, governance

- 5. The full membership is 30 members (as defined in SI2200, 2010). Members are listed in table 1. In March 2017, there were 3 MMO vacancies.
- 6. The Authority and TSB Sub-committee met quarterly. Meeting dates are in table 2. Standing Orders are in the Constitution which is on the website.
- 7. All meetings were open to the public. There were no closures for confidential matters. Committee papers were posted on the website 7 days in advance of all meetings.
- 8. Risk strategy and risk registers were reviewed by the Authority in December 2016 by the Auditors in July 2017 and are available from the Clerk.
- 9. An independent retained consultant continued a systematic analysis of all areas of the Authority's Health & Safety policy and risk assessments. The Policy is available from the Clerk. Incidents recorded were reviewed before each full Authority meeting.

Resources

- 10. The budget for 2016-17 was agreed by the Finance Sub-Committee December 2015.
- 11. There was again no increase in the levy for core costs compared with 2013-14. Therefore the budget was effectively cut again last year by the annual rate of inflation.
- 12. As resolved by the Authority in 2013, the Levy was increased by 2% and will be similarly increased by 2% per year in future to provide funding for the replacement patrol vessel.
- 13. Budget Review for the year ended 31 March 2017 is table 3.
 - a) Income from shellfish sampling was less than expected because shellfish stocks

- were low and less sampling was required. Byelaw 3 fees increased slightly as interest in cockles increased.
- b) Working surplus was 95,331, plus £60,473 set aside from 2% levy increase to fund patrol vessel replacement, total £155,803 was put into Reserves.

14. Audit

- a) Accountants Moore and Smalley LLP, conducted the internal audit on 12th July 2017.
- b) The Audit Report, Internal Controls Review and Accounting Statement to 31st March 2017 are available on request. Summary findings are:
 - i. <u>Internal Audit Report</u> Financial systems were found to be in order. A recommendation to annually review the Risk Management Strategy with the Risk Assessment which is approved annually by the Authority at the December quarterly meeting will be implemented in 2017-18.
 - ii. <u>Internal Controls Review</u> NWIFCA fully complied with relevant procedures and objectives.
- c) The Bank Reconciliation for the Year Ended 31st March 2017 (table 4) was checked by Moore and Smalley LLP.
- 15. **Officers and equipment:** NWIFCA continued to have 20 full time equivalent staff. Premises, vessels and vehicles are listed in table 5.

District fisheries

- 16. **Commercial fishing North of Haverigg Point:** trawling and netting for prawns (*Nephrops*) sole, brill and turbot, plaice, cod, codling, skate (thornback ray). Intertidal fisheries for periwinkles, cockles, mussels, angling. Potting for crab, lobster and whelk.
- 17. **Commercial Fishing South of Haverigg Point:** Boat and shore based recreational angling, cockle fisheries (Dee Estuary managed under the Dee Order) shrimps. Cockles were sparse throughout the District with no commercial stocks since 2012. Bass, plaice, dab, fluke, whitebait, mullet and codling were species mostly fished.
- 18. **Fishing vessels in the District**: Records of registered and licensed fishing vessels are maintained by MMO. The latest data dated January 2017) is shown below. Unlicensed and unregistered vessels includes hobby fishing boats and charter angling vessels.

19. **Recreational fisheries:** Non-commercial fishing included nets and lines set from the shore. Unlicensed fishing from boats appears to be increasingly popular both traditional angling but also using pots for lobster, crab and whelks. Bait collection for peeler crabs, lug, rag and other worms as well as razor clams is common.

Enforcement

- 20. Regular IFCO weekend working introduced in 2015 was effective in monitoring weekend fishing activity. Weekend working while not popular gives IFCOs greater long term certainty about their forthcoming work programmes than in the past.
- 21. NWIFCA was a pilot area in a joint MMO IFCA project to introduce an intelligence management system for England. Intelligence is securely recorded on line and shared with partners including MMO and other IFCAs.
- 22. Regular weekly tasking of IFCOs to meet intelligence received and risks identified is working well. Tasking is also shared with partner bodies and resultant joint working with MMO is increasing.
- 23. Table 6 provides inspection and compliance data for the year to 31 March 2017.

Byelaws and regulations

- 24. **Prohibition on foul hooking:** Made by the Authority in 2015 reached the advertising and formal consultation stage by March 2017. This byelaw replaces 3 similar inherited byelaws which currently cover the District. This byelaw was put on hold until other byelaws had reached the same stage to reduce advertising costs.
- 25. **Permit to fish for cockles and mussels (Byelaw 3):** A review of this byelaw started in 2015. The plan is to introduce a new flexible permit scheme byelaw. This type of byelaw has emerged as a possible route for giving IFCAs increased flexibility in byelaw measures to assist the development of more sustainable regulation of fisheries. This byelaw was put on hold as the Permit to Dredge byelaw assume higher priority (see below).
- 26. 'Permit to dredge: Threats to start dredge fishing in Cumbria area February 2015 triggered the Authority to immediately put in place an emergency byelaw to prohibit dredging. Drafting of a byelaw to replace the NWSFC byelaw 12 and extend management of dredging to the whole NWIFCA District commenced. The NWIFCA prohibition on dredging emergency byelaw (February 2016) was extended for 6 months (Feb August 2017)
- 27. Consultations with industry indicated support for a flexible permit scheme byelaw with charges for permits linked to vessel size. By March 2017, a flexible permit conditions byelaw was ready to be made by the Authority at the June 2017 meeting.
- 28. Further EU bass regulations were established for 2017 and implemented.
- 29. Species and gear landing obligations and discard plans were extended in 2017 as below.

Science and survey

- 30. Science continued to support the Authority's fisheries management decisions in 2016. The science team worked with many agencies, NGOs and stakeholders to deliver its wide remit. Main areas of work were stock assessments, field surveys, HRA, MMO Marine Licence consultations and work with developers over major infrastructure projects. Officers attended and contributed to national workshops and training events in partnership with the main Defra agencies.
- 31. Table 7 A-D report the science programme in 2016-17:
 - A. MMO licence consultation responses mostly consisting of development applications for which the Authority is a consultee;
 - B. Meetings training and workshops attended;
 - C. Surveys and inspections carried out;
 - D. Projects active in the year.
- 32. The main science priorities during 2016-17 were:
 - I. on-going work to achieve the December 2016 deadline for management of fisheries within European Marine Sites as part of the 'Defra Review'
 - II. engagement with Defra, NE, MMO over MCZ management (T2 site) and proposed T3 site designations
 - III. management of active cockle and mussel fisheries in the District including the facilitation of the multi-sectoral Bivalve Mollusc Working Group (BMWG) and carrying out Habitats Regulations Assessments prior to authorising fishing
 - IV. participation and representation of NWIFCA and marine interests in major infrastructure developments within the District, such as the North West Coast Connections project (National Grid), NuGen's new nuclear power station at Moorside and Halite Gas Storage Project, Preesall, Wyre.
 - V. NWIFCA byelaw review, stakeholder consultation and regulatory impact assessments including Emergency Dredge Byelaw
 - VI. National IFCA Technical Advisory Group (TAG) meetings
 - VII. development of recording, collation and analysis of inshore fisheries activities data for both shore and boat patrols
 - VIII. engagement with Defra, Cefas and stakeholders over EU bass measures, and proposals for future research projects including Cefas C-Bass research
 - IX. participation in meetings of Solway Firth Partnership, Dee Estuary Conservation Group, Shellfish Liaison Group, Celtic Seas Partnership
 - X. drafting of NWIFCA Recreational Sea Angling Strategy and start of engagement with stakeholders. Email: angling@nw-ifca.gov.uk
 - XI. co-working research on 3 projects relating to shellfish in Morecambe Bay EMS
 - XII. development of Conservation and Ecology pages for new NWIFCA website
 - XIII. development of NWIFCA Small Fish Survey programme
- 33. Work to deliver the Defra policy on Fisheries Management in EMS continued. By 31st March 2017 the total number of HRAs expected was 45. Once signed off by Natural England they are published on NWIFCA website and Marine Protected Area Management Huddle page (accessed by IFCAs, MMO, NE, Defra).

- 34. Individual HRAs are carried out for all cockle and mussel fisheries. In 2016-17 the following additional HRAs were conducted:
 - I. Leven Sands cockle hand-gathering April 2016
 - II. Heysham Flat seed mussel hand-gathering
 - III. South America seed mussel dredge fishery
 - IV. Fleetwood seed mussel dredge fishery
 - V. Leven Sands cockle hand-gathering Nov 2016
 - VI. Pilling Sands cockle hand-gathering Nov 2016
- 35. Shellfish (crab and lobster landings in the NWIFCA district in 2016-17 as recorded in the National Shellfish Licensing Scheme database are shown in Table 10.
- 36. Defra announced 2016 that an Inshore vessel monitoring system (iVMS) would be implemented nationally via an SI if ministerial approval were secured. The SI would require all under 12m vessels (not captured by the VMS requirements) to have iVMS fitted.

Partnership working

- 37. Working in partnership with other agencies continued to be a high government priority. In 2016-7 the Authority worked with other IFCA, AIFCA, COG, TAG, NIMEG, Natural England (NE), the Marine Management Organisation (MMO), Environment Agency (EA), Gangmaster Licensing Authority (GLA); Councils, Environmental Health Services (EHS), Food Standards Agency (FSA), Centre for Environment, Fisheries and Aquaculture Science (Cefas), Maritime and Coastguard Agency (MCA) Natural Resources Wales (NRW), Marine Scotland.
- 38. MMO: The Authority shares intelligence, tasking training with MMO. MMO is responsible for quality assurance of byelaws and appointment of members. The Authority undertakes regular joint patrols with MMO on land, in ports and using IFCA vessels.
- 39. Natural England were consulted under the 2010 Habitats Regulations on all HRA assessments of new activities in EMS or MCZ. There were 2 meetings were NE Director of marine work. Regular meetings continued with the NE Marine team.
- 40. The Authority consulted NE on all new fisheries on protected sites: SAC, SPA and MCZ.
- 41. The Authority worked with Local Authority Environmental Health Services (EHS) to ensure all Intertidal shell fisheries complied with shellfish hygiene standards as laid down in the Shellfish Waters Directive by collecting shellfish samples and assisting enforcement of the requirement for registration documents.
- 42. The Authority and Councils convened multi-agency committees as required to prepare operational plans for cockle fisheries at Pilling and Levan Island to manage the diverse socio-economic and environmental impacts of cockle and mussel harvesting. NWIFCA continued to contribute to Council chaired shellfish liaison Committees in Lancashire and other parts of District.
- 43. GLA use Gang master licences to bring more effective regulation into the shellfish industry and ensure labour is not exploited. The NWIFCA supports this policy to improve

- standards of financial and management practice and shared Byelaw 3 data with GLA and HMRC.
- 44. EA is responsible for delivery of the EU WFD and MSFD. NWIFCA continued to stand ready to undertake duties arising from these directives. NWIFCA assisted NRW and EA with management of the Dee cockle fishery and attended the Dee Estuary Fisheries Liaison group.
- 45. The NWIFCA consulted NGO in the development of policies. The Science team continued collaboration with RSPB and County WLT in the District on the Authority and the BWG to develop management plans for shellfisheries. Also North West Coastal Forum, Solway Firth Forum, Duddon Estuary partnership, Irish Sea Forum, EA Standing environment group, Dee Estuary cockle management Committee

Publicity and Communications

- 46. The NWIFCA communicated effectively with members, partners and stakeholders. The communications and engagement strategy was revised and developed in 2016.
- 47. The website at www.nw-ifca.gov.uk was redeveloped by 'IBEX creative' in 2016.to make current and background information about the Authority more accessible. Press releases for urgent communications were sent to media contacts and put on the website throughout the District.
- 48. Stakeholder consultation and discussion meetings were held as required. A text alert system was used to inform stakeholders of urgent information
- 49. The Bivalve working group a cross sectoral committee set up in 2015 to address historical conflicts between various fisheries continued work commenced development of Management plans for Morecambe Bay shellfish.
- 50. A new database was developed and commissioned by LDNP in 2016 and permit card printers were installed to provide more robust permits for holders and support efficient enforcement.

Staff Training

- 51. Officers skills were updated under the Authority's training programme. Training objectives were identified in staff reviews. The training programme included:
 - I. Defined training programmes aimed at specified roles and responsibilities provided in house, by the IFCA as a group, by MMO and outside providers;
 - II. Tailored training to meet organisation and personal objectives for each officer delivered by the Head of Enforcement;
 - III. Assessment of the Authority's existing and future skills and needs by senior officers.
 - IV. Consideration of external training available to bridge capacity gaps;
 - V. Monitoring and evaluation of training to achieve added value and effectiveness.

- 52. Two IFCOs attended the annual 5 day IFCO training course February 2017 to receive an IFCO warrant. Other mandatory and essential training was maintained. New IFCOS received mandatory internal and external training in:
 - I. Use of the Health and Safety policy,
 - II. Use of equipment,
 - III. risk management,
 - IV. operation of the enforcement policy including the IFCO code of conduct
- 53. Implementation of the FCO accreditation pilot scheme continued with the aim of creating a level 3 qualification in fisheries and marine enforcement. The aim is for 3 IFCOs to work through units 1 & 2 by March 2017. The Head of Enforcement was appointed a local assessor for this training.
- 54. New Authority members received an induction pack of information about the IFCA and the role of members. MMO provide training for new members in delivery of the role. NWIFCA provide awareness days to inform new members about the work of the Authority. An awareness day will be planned for 2016 if required.

Performance

- 55. Performance in delivery of the remit is measured locally and nationally. Local priorities for this District set by the Authority are in Table 7 A. National criteria and performance indicators set by Defra are in Table 7B
- 56. The Authority aims to be an efficient and fair regulator, which manages the exploitation of sea fisheries resources sustainably in accordance with EU and UK law and NWIFCA byelaws. The Authority has a range of compliance measures and sanctions which are regularly reviewed. Compliance measures are applied to fully meet the UK Government Regulators' Code which is at https://www.gov.uk/government/uploads/system/uploads/attachment_data/file/300126/14 -705-regulators-code.pdf
- 57. HOE had daily responsibility for Enforcement action. HOE and CEO signed off decisions on Fixed Administrative penalties and prosecutions.
- 58. **Equality Act 2010:** As a public sector body and employer the Authority complied with the Equality Act and standards.

6A: summary of quarterly reports

First quarter April - June:

- i. Opening of the Leven Island craam cockle fishery on 4th April.
- ii. First cockle fishery in Morcambe Bay since 2008.
- iii. Numbers of gatherers varied from 0 50 depending on tides and demand.
- iv. The cockle closed season commenced 1st May.
- v. Low level of Foulney mussel activity continued dependent upon tidal conditions.
- vi. Nephrops fishery began April, within and outside the district.
- vii. Vessel landings up to 400 stone for 3 4 days fishing.
- viii. Lobster and crab fishing gear returned to the water in May June.
- ix. Landings moderate.
- x. Whelk landings into Whitehaven were good 8 10 tonnes at a time. Codling and plaice were caught by anglers throughout the district.

Second quarter July - September

- i. Moderate landings of nephrops, shrimps, lobster and crabs.
- ii. Poor bass returns across the District.
- iii. Light inter-tidal hand gathering for mussels throughout the quarter.
- iv. Heysham mussel seed fishery continued until mid-September.
- v. South America, dredge fishery commenced 11th July. Perch Scar / Black Scar later.
- vi. The renewal of NWIFCA byelaw 3 permits for the 2016/17 season, were issued via the new database and in a plastic credit card format.
- vii. Cockle beds closed season continued to end august, then replaced by Byelaw 3 closures.
- viii. Shellfish surveys throughout the quarter
- ix. Local Authority Environmental Health sample collection continued throughout the district.
- x. Joint enforcement operations were carried out with the MMO and EA.

Third quarter October - December

- i. Good catches Thornback ray.
- ii. Shrimping was variable, tractors had reasonably success.
- iii. Potting continued to about end November.
- iv. Licensed netting vessels continued fishingduring the quarter.
- v. Anglers were active, mainly at weekends.
- vi. Mussel gathering reduced significantly over the quarter as stock declined.
- vii. Very sporadic bass catches from boats, shore netting slightly better. Bass continues to maintain its high media profile.

Fourth quarter January – March 2017

- i. Thornback rays were dominant catch in the northern sector,
- ii. Shrimping ended with moderate catches but small average size.
- iii. Pilling and Leven cockle fishery opened fishing effort was low.
- iv. Mussel gathering was limited due to very little stock.
- v. Angling effort continued low throughout the district.
- vi. Contributed to a national intelligence management pilot project in cooperation with the MMO and Natural England and other northern IFCAs.
