#### **General Update**

- Senior IFCO Erik Thinnesen has returned to work after a successful heart operation and Deputy Master of the patrol vessel Alan Forster has recovered sufficiently from a stroke in 2017 to return to full duties.
- Patrol vessel crew have decommissioned "Solway Protector" so she is ready for sale.
- Crew also committed much time to monitoring and assisting Holyhead Marine Services to complete the new patrol vessel "North Western Protector" to specification.
- IFCO's were issued with body worn video cameras in March. These are routinely worn on patrols and are already improving interactions with fishermen. Hopefully they will improve safety and assist with gathering evidence for successful prosecutions.
- Five officers attended and passed the IFCO training course at the beginning of February.
- The Authority was pleased to appoint Matthew Burdekin as an IFCO in April. Matt previously worked for NWIFCA as an IFCO for two years and has completed training.

#### **NIMEG**

Head of Enforcement attended the quarterly meeting of the National Inshore marine Enforcement Group in March. A number of important issues were discussed.

- Baseline Personnel Security Standard (BPSS check) is to be in place across IFCA's by the
  end of 2018 for all new personnel. This would bring NWIFCA up to the same standard of
  other partners. It involves verification of identity, nationality, employment status and
  criminal record.
- A code of conduct for inspections is to be introduced. Agreed that all IFCA's should present consistency for stakeholders. It was agreed to develop a standard enforcement policy across IFCA's.

#### **Health and Safety**

Risk Profiles for the Authority were developed throughout the quarter, with the spot check safety assessments being developed and key performance indicators being identified. There are currently 10 proactive indicators being listed and developed and a further 3 reactive indicators which will be monitored on a monthly basis.

Lone working is an example of an issue identified through Health and Safety meetings. All lone working is identified through a weekly tasking document and a buddy system has been implemented. The Head of Enforcement keeps a log of any lone working and a record of staff logging in and out of any activity. Therefore it is possible to assess if levels of lone working are increasing.

#### **Cockle Fisheries**

#### **Pilling Cockle fishery**

Effort at the Pilling cockle fishery decreased earlier in the quarter with only small numbers of gatherers attending regularly. Fishing increased exponentially during the last two weeks of April due to market demand from processing factories. During this period the HoE responded to intelligence received by tasking almost every tide for this final period of the fishery. As a result a large quantity of undersize cockle was detected and relayed to the beach. Investigations are continuing with regard to other offences detected.

There were a number of complaints raised by local residents in the final two weeks, mostly due to the increased activity. Largely this was surrounding issues out width of NWIFCA's remit, however where possible IFCO's did liaise with fishermen and merchants to alleviate these issues such as littering.

#### Flookburgh Cockle Fishery

The Flookburgh cockle bed continued through the end of winter with a steady low effort mostly by local fisherman, again as with Pilling towards the end of the fishery effort increased due to industry demand. However due to the larger cockle available there were no issues with minimum landing size.

#### **Leasowe Cockle Fishery**

The Leasowe cockle bed has only seen sporadic interest from Byelaw 3 permit holders through this quarter.

#### Byelaw 3 returns

- Submission of Byelaw 3 returns dropped significantly in the Spring
- Sanctions were unable to be escalated in February/ March due to issues with the Royal Mail.
- The Byelaw 3 returns sanctions have been included in this quarters report as the actual offence took place in April, although the sanctions were imposed in early May.
- IFCO Matt Burdekin is now responsible for the monthly compiling of B3 returns.
